Highway Report (7:08)

Highway Superintendent (HS) Treadway reported that the crew has been preparing Hutton Square Road for paving in late October. Black Point Road was shimmed in cooperation with the Town of Ticonderoga. Roadside mowing continues as well as winter preparations on the dirt roads. The new tractor got a new rim. The Road Agreement with CHPE was briefly discussed along with adjustments for culverts that the Town would like to add. The Town would provide the culverts to be replaced. HS Treadway thought about 10 culverts would need to be replaced along the CHPE work route.

Planning Board Report (7:18)

Planning Board Chairman Bill Brown reported that the PB will have their monthly meeting in the coming week. There will be a public hearing for the Travis Whitford project on Peterson Road. Adirondack Camp needs to resolve an issue before their public hearing. Darrell Wilson's project is also awaiting approval from the APA. Chairman Brown recapped last month's meeting. With the passing of the Solar Law, The Solar Checklist has been posted to the Planning Board page on the Town website for resident use.

Old Business (7:22)

Intermunicipal Agreement with the Town of Ticonderoga for law enforcement at the Ticonderoga Beach which is technically located within the borders of the Town of Putnam. The agreement would expedite law enforcement response at the Ticonderoga Beach. Various details are being investigated and worked out, set up for the 2023 season is the focus.

CHPE Road Agreement- The bond amount is to be determined. Escrow will be \$10,000 (Ten thousand dollars) The escrow is the same amount for all towns on the route. Supervisor Wilson is seeking assurances in the form of a bond from CHPE that the Town will be able to repair or replace any disturbance left by CHPE.

The Board of Assessment Review has a vacancy. The successful candidate will finish out a term that has been vacated; the term will expire 9/30/2025. Candidates who have applied in the past along with new candidates are being reviewed. An appointment is expected at the October meeting. Training will take place in April prior to the 2023 Grievance Day at the end of May. Supervisor Wilson will reach out to candidates and ask them to attend the October meeting.

Old Business revisited (7:50)

Budget- A gap in revenue has occurred, with the expiration of a grant in 2021 that New York State provided to the Town for the boat launch attendant's wages since the inspection program began. That gap is \$27,500 or 2.4% of the budget. In addition to wages paid to the boat launch attendants, the Town also pays unemployment wages in the winter months through New York State Unemployment. The Town is self-insured and is billed by New York State for 100% of the unemployment wages paid out through the State. The additional costs for unemployment are being tallied and are expected to be an additional \$10,000 + annually to the boat launch operating costs. Contingency funds were used last year to cover the shortfall after the Town learned that the grant money would no longer be available, however that is not a sustainable source of funding. A few options were examined, including breaking the tax cap and taxing residents to cover 100% of the current costs, reducing hours and days of operation during the "off" months of May, June, September, October when the usage is limited and full operation during July and August when the vast majority of the usage occurs, a fee to launch by either a seasonal permit or day permit. All options are being investigated to keep the launch open and sustain it economically if at all possible. Putnam and Hague are the only town launches on Lake George, all other launches are State operated and are funded by the State.
