#### Courtesy of the floor

Bert Windle addressed the Board about a mention in the prior month's minutes of a revaluation of the Town. Mr. Windle felt the last revaluation was poorly executed, which resulted in many questionable assessments and Board of Assessment Review petitions. Mr. Windle closed by stating he is vehemently opposed to a revaluation.

Recreation Supervisor Mary Jane Dedrick thanked Highway Superintendent Gary Treadway for his help and assistance during the summer at the beach and boat launch. Ms. Dedrick also thanked Councilman Charlie Bain, and Town Clerk Darlene Kerr for filling in at the boat launch when there were staffing shortages.

Councilwoman Carole Schneider commented she had ridden around in the construction area the prior weekend. Councilwoman Schneider suggested that the residents on Lake Road should be compensated by CHPE for the intrusive and extensive interruption to their lives as a result of the CHPE project. Councilwoman Schnieder also thanked Highway Superintendent Treadway for his selfless actions when a propane truck turned over on Gull Bay Road and was in flames. "You saved a man's life and should be recognized, you're a good man".

Bert Windle addressed the Board a second time adding to comments made by Leslie Bain at the prior month's meeting about illegal immigrants and who will pay the expense if they're sent to Washington

County. Mr. Windle doesn't support the intake of illegal immigrants in Washington County as stated by Leslie Bain the prior month.

Karl Ohly advised the Board and those attending that his dogs have killed a rabid coyote and racoon in recent days, as a PSA. Dr. Ohly also stated that if any immigrants need to be dropped off in Putnam, his farm will happily take them in as workers. Dr. Ohly stated he noticed there was a farm building applied for with the Putnam Planning Board, and that they were "forced" to go through Site Plan Review. Dr. Ohly asserted that this was an illegal action by the Town Planning Board because the applicants' building is agricultural. The applicants are operating a farm. He stated, "I think this needs to be stopped".

#### <u>Highway Report</u>

Highway Superintendent (HS) Gary Treadway reported the crew has continued to work on Sagamore Road ditching and cutting brush. Sagamore Road will be shimmed before winter then topped next year. The Gradall broke down putting the crew behind. A mechanic will look at the Gradall in the coming week. HS Treadway will try to borrow equipment from another town to finish the work if necessary. Councilwoman Schneider asked about renting equipment. HS Treadway advised it was more expensive to rent than previously anticipated. There are culverts that need to be replaced before winter. During the down time the crew has been preparing the equipment for the winter season.

#### Planning Board Report (7:25)

Planning Board Chair William Brown reported that the first project presented to the Planning Board was by Joan Austin for a 40' X 60' building on a concrete pad for storage. There will be no electricity or water. A public hearing for the Austin project was waived and the project was approved as presented. The second topic discussed was an unapproved build on Black Point. The APA has sent a communication to Mr. Agree asking for him to contact the APA. The status of that contact is unknown as of the meeting. Work appears to continue despite a stop work order.
