A LOCAL LAW ESTABLISHING A REAL PROPERTY TAX EXEMTION FOR QUALIFYING SENIOR CITIZENS IN THE TOWN OF PUTNAM, COUNTY OF WASHINGTON, STATE OF NEW YORK

BE IT ENACTED BY THE TOWN BOARD AS FOLLOWS:

SECTION 1.

The intent of this local law is to provide a real property tax exemption to certain senior citizens in accordance with Section 467 of Real Property Tax Law, and certain disabled persons, in accordance with Section 459-c of Real Property Tax Law, and to increase the income limits to allow the exemptions to be distributed in a more fair and equitable manner.

a: Effective March 1, 2023, the Town of Putnam shall grant a real property tax exemption to certain individuals sixty-five (65) years of age and over, in accordance with Section 467 (1)(b) of the Real Property Tax Law.

b: Effective March 1, 2023, the Town of Putnam shall grant a real property tax exemption to certain persons with disabilities and limited incomes, in accordance with Section 459-c of the Real Property Tax Law.

SECTION 2.

Effective_____DATE__, the maximum income eligibility level for the 467 and 459-c exemptions shall be as follows:

SECTION 3.

All other provisions of Section 467 and 459-c of Real Property Tax Law of the State of New York shall be in effect for the purpose of Town real property taxation in the Town of Putnam.

SECTION 4.

This exemption shall be extended to a legal residence owned as a cooperative apartment as provided in such Section 459-c.

SECTION 5.

This local law is specifically intended to be in effect for the March 1, 2023, taxable status date for applications received for preparation of the 2023 assessment rolls.

SECTION 6.

This local law shall take effect immediately upon its filing in the Office of the Secretary of State.

SECTION 7.

In the event of a conflict or inconsistency between this Local Law and any previous Local Law or Resolution, the terms of this local law shall govern.

EFFECTIVE DATE:

This Local Law shall take effect immediately upon filing with the Secretary of State.
